The conference will provide opportunities to meet, network, and share ideas with other people from Emerging AAC Nations. Many of the conference presentations will focus specifically on developing and enhancing strategies to further develop AAC in Emerging Nations.

We invite members from emerging countries who feel they will actively work towards the ongoing development of AAC in their countries to apply.
