Chapter News



In November 2016 the Danish Government changed the composition of some ministries. ISAAC-Denmark therefore wrote to the new ministers for the Ministry for Children and Social Affairs, the Ministry for Higher Education and Science, the Danish Ministry of Education and the Ministry of Health and Health-related Social Services for the Elderly. We congratulated and welcomed them, reminding them of the important job they are going to have regarding a special group of Danish children, youngsters, grown ups and elderly citizens: namely those with complex communication needs. We told them about the special knowledge and interventions they need in order to experience the same kind of freedom of speech as all Danish citizens. We informed them about ISAAC and its NGO status in the UN, based on a worldwide volunteering effort.

We also mentioned the complex status of the AAC area and that different aspects belong to different ministries.

We offered our contribution based on relevant issues about AAC. We received friendly thank-you emails. In particular, the Minister for Children and Social Affairs shared her positive reflections on the focus of complex communication needs.

At the time of writing, we are looking forward to our national conference on March 20-21, 2017. To date we have more than 165 participants, which is very satisfying. [For updates, follow ISAAC Danmark on Facebook.]

ISAAC was pleased to host a webinar on February 22, 2017, by and for **Spanish-Speaking ISAAC supporters**. The topic was, "Introduction to AAC Systems and Communication in Patients with ALS." Presented in cooperation with <u>Irisbond</u>, this webinar featured two speakers: Sol Solis, Speech-Language Pathologist (Spain) and Leticia Rodriguez, Occupational Therapist (Argentina). Fifth Pacific Regional Conference on Disability February 20th - 23rd, 2017

I was excited when I was invited to attend the 5th Pacific Regional Conference on Disability in Samoa. People from 18 different countries in the Pacific were participating.

The Tanoa Tusitala Hotel in Apia was the venue. The venue was very accessible and I was surprised most of the Hotel staff knew basic signs. It must be part of the Samoan culture to learn sign language.

Although there were many hearing impaired people at the conference, I was the only person there who uses AAC. I was asked to do a presentation in the "Information and Communication Technology" elective. My emphasis was that communication technology is getting more affordable and it soon will be within reach of those in the Pacific region who cannot yet afford it.

The theme of the conference was "Building a more Inclusive and Equitable Pacific". The conference was organized by the Pacific Disability Forum (PDF). The PDF is funded by a grant from the Department of Foreign Affairs and Trade of the Australian Government. The conference had close to 200 delegates from 18 countries. Last year the Samoan Government ratified the Convention on the Rights of Persons with Disabilities (CRPD). The Minister for Women and Disabilities attended the conference on at least two days.

It was wet season in Samoa. It rained and rained. Walkways around the hotel were covered so we were kept dry. Ropes were placed around poles in the walkways so that people with visual impairments could navigate themselves to various venues around the Hotel.

The Women's Conference was held before the main conference. There was also a Youth Conference held at same time in a venue 200 metres away. I attended the Women's Conference.

While most Western governments debate climate change, the Pacific Islands are tackling this on the front line. The islands of Kiribati and Tuvalu will be the first to disappear. The PDF and other Pacific Islands Disabled Persons Organizations (DPOs) are fighting hard to get people with disabilities included in disaster plans.

After Cyclone Winston in Fiji in February 2016, women, children and people with disabilities were kept out of the decision-making process for disaster plans.

Since that time funding has been given by ActionAid Australia to inform women about weather patterns and what to do in disasters. This included disaster plans for children and people with disabilities. The men wanted to be involved as they too were largely ignored by decision-makers, so additional meetings were organized for the men.

Violence against women was another major issue that needed greater awareness. There was recognition that research was needed into violence against women with disabilities. It was also recognized that there were

strong women in leadership positions within the PDF, but they needed to access mainstream women's networks to get a stronger voice.

The main conference was opened by the Head of State of Samoa, His Highness Tui Atua Tupua Tamasese Efi.

The United Nations Special Rapporteur on the Rights of Persons with Disabilities, Ms Catalina Devandas Aguila, gave the keynote address to the main conference. Catalina had flown from Switzerland via Costa Rica to be at the conference. She spoke about the CRPD, saying 172 member states have now ratified the CRPD. The Samoan Government ratified the CRPD last year. The challenge is now is to move governments into legislative reform and action.

Catalina urged us all to participate, to take our "place at the table," to do the data collection and to use the International organizations if needed. There was a sense that CRPD had been implemented, with only Fiji, Tonga and Solomon Islands still to ratify the Convention. Now we move into the awareness phase.

During the conference. issues of climate change, employment opportunities, advocacy, access and leadership were discussed.

Disaster Management Plans, Risk Reduction and Recovery plans were again priority learning and we were to remind governments to "leave no one behind".

The final session of the conference concluded with what we could claim:

- Claim progress
- Claim the United Nations CRPD
- Claim Development
- Claim Self-Advocacy & Advocacy Services
- Claim Women "Look for us and include us."

The comprehensive outcome statement from the conference was handed to the Deputy Prime Minister of Samoa, Hon. Fiame Naomi Mata'afa, who closed the conference. The outcome statement will be taken to the Pacific Leaders' Forum.

The Australian Communication Access Symbol in 2016

2016 has been another exciting year for Australia's Communication Access Symbol.



In addition to the symbol being registered as a trademark since 2014 in compliance with the Madrid Protocol (1989), the *rules and standards* underpinning communication access have now been accepted for registration with the *Australian Consumer and Competition Commission*. This means that any place where the Communication Access Symbol is displayed must be in compliance with the registered standards for communication access.

In 2016, Scope formalized the process of awarding the symbol through the award of three different types of communication access licences. The type of licence awarded depends on the size of the business, and the annual review requirements that have been put in place. We now have over 200 businesses, services or organisations in Victoria, Australia, that have been awarded a Communication Access Approved User Licence, and over 280 customer service points that have been assessed and awarded the Communication Access Symbol.

The Australian Communication Access Symbol in 2016 ... *continued*



In **2016**, Scope awarded Communication Access Approved Organisation Licences to a number of *organisations* for the first time. V/Line regional rail services (390 frontline staff trained in disability and effective communication strategies), Public Transport Victoria Call Centre (150 staff trained in effective phone communication for customers who have communication difficulties), Public Transport Victoria Hubs (40 staff trained in disability and effective communication) and the Victorian Equal Opportunity and Human Rights Commission (60 staff trained in disability and effective communication), were among those awarded an Approved Organisation Licence.

The importance of communication access and a basic human right is receiving increasing recognition with government, businesses and community services.



In addition, in the Speech Pathology 2030 report - making futures happen, Speech Pathology Australia has identified that first of eight key strategic priorities is to create communication accessible communities:

"We will ensure through building communication accessibility that everyone is treated with dignity and respect: communication partners are skilled listeners and talkers (e.g., they provide extra thinking and talking time, they know not to finish off someone's sentences, etc.) and other methods of communicating (e.g., communication boards, speech generating devices, switches and eye-tracking devices etc.) will be understood, and if required, their use supported." (vii, Speech Pathology 2030, making futures happen)

The Australian Communication Access Symbol in 2016 ... *continued*

2016 has built on the awards already received by the communication access team at Scope and by its partners.



In 2013 Scope's communication access assessor team won the Excellence in Improving Participation Award at the prestigious Victorian Disability Sector Awards. In 2014, Communication Access was a finalist in the National Disability Awards. In 2015 and 2016, Scope staff members won Lifetime Achievement Awards for work in communication access at the Victorian Disability Sector Awards. Finally, V/Line was a finalist in the 10th National Disability Awards 2016 for achievements in communication access, and was recognized as one of the four most outstanding organizations nationally in the Excellence in Inclusive Community Design Award category. V/Line was also the winner of the state Award for Corporate Social Responsibility from the Australian Marketing Institute Awards. These are highly commendable achievements and great recognition for the communication access program and the team at V/Line. The importance of V/line's achievements are reflected in a growing communication access "movement" in the public transport sector, with many transport providers working towards creating communication accessible services.
