Summary

This presentation will focus on the support of effective patient provider communication across medical settings for children and adults with complex communication needs. Communication vulnerable patient groups will be described, five communication intermediaries groups will be described and the roles of these intermediaries will be outlined for different communication vulnerable people and the settings in which they are served. Medical procedures such as the various types of referrals will be reviewed. Finally, a range of communication support goals, policies, and strategies for these patients and their providers will be reviewed and demonstrated.

Presenter Bio:

David R. Beukelman, PhD, CCC is a speech-language pathologist who specializes in augmentative and alternative communication (AAC) and communication disorders associated with neurological conditions. He is currently a Senior Researcher in The Institute for Rehabilitation Science and Engineering at Madonna Rehabilitation Hospital in Lincoln, Nebraska. Previously, he was a faculty member of Communication Disorders at the University of Nebraska-Lincoln, Director of Research and Education of the Communication Disorders Division, Munroe/Meyer Institute of Genetics and Rehabilitation at the University of Nebraska Medical Center, and Director Speech Pathology and the AAC Center in the Department of Rehabilitation Medicine at the University of Washington Medical Center. He has co-authored textbooks focused on AAC, motor speech disorders, and patient provider communication.
