Maintaining Communication Access, Encouraging Disaster Preparedness: A Conversation on Emergency Preparedness and People with Communication Disabilities

ABOUT THE PRESENTERS:

Pam Kennedy serves as a Disability Advocate, Augmentative and Alternative Communication, Emergency Management and Crisis Intervention Specialist. She is an invisible frontline worker and advocate who has specialized in emergency preparedness, disaster response, patient-provider communication and threat assessments for vulnerable populations since 1992. She has survived disasters in North Dakota and Georgia, sharing her expertise to save lives as infrastructure collapses.

Marcie Roth is Executive Director and Chief Executive Officer for the World Institute on Disability (WID), a highly regarded global public policy center. Appointed by President Obama to the U.S Department of Homeland Security Federal Emergency Management Agency (FEMA) from 2009 to 2017, she served as Senior Advisor to the Administrator and as the congressionally mandated Disability Coordinator for the agency. While at FEMA, she established the Office of Disability Integration and Coordination (ODIC), serving as its Director. Under her leadership, ODIC led national transformation towards integrating the access and functional needs of the whole community throughout emergency preparedness and disaster response, recovery and mitigation

Shaylin Sluzalis and Germán Parodi, Co-Directors of the Partnership for Inclusive Disaster Strategies, come from Independent Living movement and disability rights backgrounds. Germán acquired his spinal cord injury in 2001. Shaylin has invisible disabilities and grew up alongside her disabled sister, Brittani. Both their experiences led them to work for Centers for Independent Living and evolve into disability rights activists with <u>ADAPT</u> where they met and fell in love. Shaylin and Germán's journey in inclusive emergency management began in 2017 when they were deployed to Puerto Rico following Hurricane Maria as disabled first responders meeting the needs of disaster-impacted people with disabilities.

SEMINAR DESCRIPTION:

As the 2022 hurricane season opens, it is time to provide critical information about disaster/emergency preparedness for people with disabilities and, especially, people with significant communication needs. This session will be a panel discussion moderated by the cochairs of USSAAC's Disaster Relief Committee. The panel will be comprised of internationally known leaders in the area of disability, disaster preparedness and response, and disaster survivors who use AAC.
