Educators and SLPs are Encouraging Hands-Free Walker Mobility for Students with Complex Communication and Physical Needs!

ABOUT THE PRESENTER:

Christine is an occupational therapist with more than 35 years of experience. She is currently in private practice and a consultant at the Bridge School in Hillsborough, California. She has worked in a variety of settings, including California Children's Services, a High Tech Center and at the former Rehabilitation Engineering Center at Children's Hospital at Stanford, where she was author and principal investigator of two Department of Education (NIDRR funded) grants: "Transitional Ortho-therapeutic Walker (TOTWalker) for Preschool Children with Cerebral Palsy," and the "Transitional Powered Mobility Aid" (TPMA). She is a frequent lecturer at national and international conferences (ISAAC, ATIA, CTG, ISS, AAC by the Bay) and universities. She has authored the 3rd through 7th editions of the chapter "Mobility" in Occupational Therapy for Children and Adolescents.

SEMINAR DESCRIPTION:

This workshop will describe a multidisciplinary (SLP, OT, ATP, Teacher) Walker Mobility Program for preschool and elementary students with physical disabilities implemented at the Bridge School since 2006. The team recognized the developmental, social, physical, psychological and educational benefits of imbedding self-initiated mobility into the curricula. Diagnoses of these children include cerebral palsy (CP) and cortical vision impairment (CVI). Students participate in self-initiated mobility experiences through the use of hands-free support walkers such as the Pacer, KidWalk, ProneWalk and Grillo.
